Notes:

- Membership is on a January 1 to December 31 basis.
- Base dues are prorated on a quarterly basis. If a company joins in the 3rd quarter of given year, they owe dues for the 3rd and 4th quarter of that year. Companies joining the Mid-Atlantic Chapter in December, and paying base dues in full, will have those dues applied to the following year, but their membership will begin immediately (i.e. dues will not be prorated for the 4th quarter in the year they join).
- Admixture, Aggregate, Fly-Ash, Material and Equipment Allied members that do business exclusively in one Chapter or do business in two Chapters if the neighboring Chapter/State is located within 60 miles of the primary place of business are designated as “Local Allied Members.” For companies that qualify as “local” and join ACPA National through the Chapter, the Chapter forwards \$465 in dues to National on their behalf.
- Admixture, Aggregate, Fly-Ash, Material and Equipment Allied members that do business within multiple Chapter areas are designated as “National Material Members” or “National Equipment Members.” They must join both the Chapter and National. After joining, all subsequent dues will be invoiced directly by National for the minimum dues in the company’s Sales Category tier (see National Dues structure) and National will forward the Chapter dues to the appropriate Chapter.
- All Ready-Mixed Concrete, Trucking, Bonding, Association, Associate, and Consultant classifications of allied members can join the Mid-Atlantic Chapter and ACPA-National.

NOTE: This dues structure has changed and becomes effective January 1, 2014 per our Affiliation Agreement with National ACPA approved on November 21, 2011.
